This form can be used only to establish a Primary User for a MassHealth provider ID and service location (PID/SL) upon enrollment in MassHealth. The form must be submitted with your MassHealth provider enrollment application. If you have already established a Primary User for an existing PID/SL and want to change the Primary User for that location, please complete the Existing Provider Modification Data Collection (POSC-DC-PM) Form at [www.mass.gov/RegisterMassHealthProvider](http://www.mass.gov/RegisterMassHealthProvider).

Providers can conduct day-to-day business with MassHealth electronically through the Provider Online Service Center (POSC), point-to-point connectivity, and MassHealth’s Interactive Voice Response (IVR) system. All users are required to have a User ID and password to access these systems. Please identify a Primary User (account administrator) for your organization. The Primary User will be the person in your organization who will be responsible for managing access to your organization’s data on the POSC. This includes the creation and deactivation of users’ accounts and password resets.

Please complete this form to obtain a User ID and password for the Primary User. Once the Primary User is registered, that person will need to create subordinate IDs for all other users within your organization and authorize access for business partners, such as billing agencies. The Primary User must assign a backup Primary User to perform Primary User responsibilities in the Primary User’s absence.

**Please note:** It is important to ensure that access to your data is securely managed by the Primary User.

## INSTRUCTIONS TO COMPLETE THE FORM

Complete all required sections and fields within the form. Complete the optional fields as applicable.

FIELD/Check Box	DESCRIPTION
Establish a Primary User for this new service location	Select this option if you are establishing an initial Primary User for this new service location.
Assign an existing Primary User to this new service location	Select this option if you want to assign an existing Primary User that currently manages other service locations to also manage this new service location.
Provider's Name	Enter the Doing Business As (DBA) name of the provider or organization.
Primary User's Last Name	Enter the Primary User's last name.
Primary User's First Name	Enter the Primary User's first name.
Middle Initial (optional)	Enter the Primary User's middle initial (if applicable).
Month and Date of Birth (MMDD)	Enter the Primary User's two-digit month and two-digit date of birth.
User-Defined Unique Four-Digit PIN	Enter the Primary User's self-defined four-digit Personal Identification Number (PIN).
Work Zip	Enter the Primary User's work location zip code.
Primary User's Current Business Email Address	Enter the Primary User's current business email address.
Existing Virtual Gateway User ID (optional)	Enter the Primary User's existing Virtual Gateway User ID. (Enter this information only if you selected the option to assign an existing Primary User to your new service location.)

Signatures: Both the Primary User and the Provider/Organization's signatory **MUST** sign the form.

### IMPORTANT NEXT STEPS

Upon approval of your application, MassHealth will manually create a User ID and a password for the initial Primary User established for this PID/SL. The Virtual Gateway will then send the User ID and password to the Primary User at the email address provided on this form. Please note: Existing Primary Users assigned to a new service location will **NOT** receive a new user ID and password.

After receiving the User ID and password, the Primary User must take the following steps immediately.

- **Change the password:** Once the Primary User has registered, they must go to the Virtual Gateway (VG) to change the password. A series of "I forgot my password" questions under the "Manage My Profile—Authentication Questions" tab must be answered before the password can be changed. The user will also be prompted to review and accept the VG Terms and Conditions.
- **Assign an alternate Primary User:** The Primary User must assign a backup Primary User to perform Primary User responsibilities in the Primary User's absence. The Primary User must **NOT** grant every user full access to the POSC features. The Primary User must assign access only to those specific users who need that access to perform their functions.
- **Create and link subordinate IDs:** Once registered, the Primary User must create a user account for each individual user in the organization needing access to the POSC and grant the appropriate permissions. The Primary user can also grant permission to other entities who conduct business on the organization's behalf. This is accomplished by linking the user ID of staff within the other entity's organization to the appropriate PID/SL and assigning the POSC services the user will be able to perform. The Primary User can also link an individual user who already has a User ID to a new provider by selecting the "Administer Account" link.

**Please note:** In accordance with the VG Terms and Conditions, all MassHealth providers, trading partners, and relationship entities that have been assigned a User ID and Password to access the VG-hosted MMIS Provider Online Service Center (POSC) and connectivity methods are solely responsible for the use of that User ID and must not share it with any other individual. Each user is prompted to agree to the VG Terms and Conditions upon initial sign-in on any Commonwealth VG-hosted application (for example, MMIS). Job aids related to logging on to the VG and resetting a forgotten password can be found at the Virtual Gateway login help for providers and state agency staff page. Sharing User IDs is a violation of the policy. Any user who violates the VG Terms and Conditions will be subject to termination of their User ID.

## **PRIMARY USER RESONSIBILITIES - ONGOING MAINTENANCE**

The Primary User within each organization is responsible for managing users' access to the organization's information in the POSC. This includes all information data entered or exchanged with MassHealth via the POSC and its connectivity methods. It is imperative that the Primary User accurately maintain access to the POSC and ensure the following.

- 1) Only the backup primary may be granted access to perform "manage subordinate accounts" functions. Any other user account with this permission must be modified to remove it to ensure that no other user has access to modify user accounts for the organization.
- 2) Each user/relevant staff member within the organization is notified of the Primary User and backup administrator, the role of the Primary User, and the organization's protocols related to User ID access and password resets.
- 3) Each person who requires access is assigned a unique User ID. Sharing User IDs is not allowed.
- 4) Do not create more than one User ID per person. Only one User ID per user is allowed.
- 5) Each user is told that they are responsible for the use of the User ID and must not share it with anyone else.
- 6) User IDs for staff that no longer work for the organization, or affiliates that no longer perform functions on behalf of the organization, are promptly deactivated so that they can no longer view, submit, or receive information on behalf of your organization.
- 7) Subordinates are only linked to the PID/SL that they are entitled to access or to perform POSC functions.
- 8) Passwords are reset for subordinate users
- 9) Establish and maintain a quarterly, semi-annual, or annual review and alignment of all user access to safeguard the organization's MassHealth information.

If the Primary User and assigned backup leaves an organization, that organization must immediately identify a replacement Primary User, complete the Existing Provider Modification Data Collection (POSC-DC-PM) Form at [www.mass.gov/RegisterMassHealthProvider](http://www.mass.gov/RegisterMassHealthProvider), and submit it to MassHealth at [EOHHS-IT-CustomerService.Hancock@mass.gov](mailto:EOHHS-IT-CustomerService.Hancock@mass.gov) to officially notify the agency of the change.

## **KEY REMINDERS**

- You, the Primary User, are the gatekeeper of your organization's information in the POSC. Please ensure that access to that information is timely and accurately maintained.
- Your User ID and password will give you access to the POSC. You will also need these credentials to access the IVR system to verify member eligibility.
- When using the POSC, you will need your provider ID and service location number (PID/SL) to view reports, remittance advice, letters, direct data entry (DDE), and Health Insurance Portability and Accountability Act (HIPAA) transactions. MassHealth will mail the PID/SL to you separately.
- Please remember that you must submit your national provider identifier (NPI) on HIPAA batch transactions. If you are an atypical provider (that is, not required to have an NPI), please include your PID/SL on your batch transactions.
