You are advised that you have the right to appeal this decision under M.G.L. c. 30A to Superior Court within thirty (30) days upon receipt of this notice.

Donald Edwards Enterprises Inc. dba Gov. Bradford Rest. (the "Licensee") holds an all alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, October 4, 2011, regarding an alleged violation of M.G.L. c.138, §34. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Jamie Binienda's Compliance Check Field Report.

FACTS

- 1. On June 25, 2011, at approximately 7:33 p.m., Commission Investigators investigated the business operation Donald Edwards Enterprises Inc. dba Gov. Bradford Rest.
- 2. An underage operative, working with the investigators, was in possession of a Blue Moon draft. The underage operative was not asked for identification.
- Administrative review of the licensee's files indicates a prior violation in October 2008.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated Massachusetts General Laws c. 138, §34. The Commission suspends the license for six (6) days of which three (3) days will be served and three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
