DECISION

PACK VENTURES LLC D/B/A TIN PAN ALLEY 269 COMMERCIAL STREET PROVINCETOWN, MA 02657

LICENSE#: 1004-00169

VIOLATION DATE: 08/01/2017 HEARING DATE: 10/31/2017

Pack Ventures LLC d/b/a Tin Pan Alley (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission (the "Commission" or "ABCC") held a hearing on Tuesday, October 31, 2017, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Binienda's Report.

The following documents are in evidence:

- 1. Investigator Binienda's Compliance Check Field Report; and
- 2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

- 1. On Tuesday, August 1, 2017, at approximately 6:28 p.m., Investigators Kenny and Binienda ("Investigators") investigated the business Pack Ventures LLC d/b/a Tin Pan Alley.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a Corona Light beer for six dollars (\$6.00). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Therefore, the Commission suspends the license for a period of three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
