## **DECISION**

RLJC INC. D/B/A 1620 BREWHOUSE 214 COMMERCIAL STREET PROVINCETOWN, MA 02657 LICENSE#: 06756-RS-1004

RLJC Inc. d/b/a 1620 Brewhouse ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, September 24, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigator Binienda and Velez's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Binienda & Velez's Minimum Purchase Age Compliance Check Field Report, 6/19/2024;
- 2. ABCC Licensing Authority Certification, Transfer of License Approved, 5/4/2022;
- 3. Licensee's Stipulation of Facts.

## **FINDINGS OF FACT**

- 1. On Wednesday, June 19, 2024, at approximately 6:30 p.m., Investigators Binienda and Velez ("Investigators") conducted a compliance check at RLJC Inc. d/b/a 1620 Brewhouse.
- 2. An underage operative, working under the supervision of Investigators, was served an alcoholic beverage, one High Noon Watermelon Hard Seltzer. The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 12 since 2022 with no prior violations.

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING.**
