DECISION

ROSS'S GRILLE LLC D/B/A ROSS'S GRILLE 237-241 COMMERCIAL STREET, #25 PROVINCETOWN, MA 02567

LICENSE#: 1004-00122

VIOLATION DATE: 08/01/2017 HEARING DATE: 12/19/2017

Ross's Grille LLC d/b/a Ross's Grille (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, December 19, 2017, regarding an alleged violation of 204 CMR 2.05 (2) — Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 — Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Binienda's Report.

The following documents are in evidence:

- 1. Investigator Binienda's Compliance Check Field Report; and
- 2. Licensee's Stipulation of Facts.
- A. Letter 12/19/2017 from Owner.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

- 1. On Tuesday, August 1, 2017, at approximately 6:45 p.m., Investigators Kenny and Binienda ("Investigators") investigated the business Ross's Grille LLC d/b/a Ross's Grille.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a Bud Light beer for six dollars (\$6.00). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business approximately 17 years with no prior violations, the Commission issues a **WARNING**.
