**DECISION**

**SAKI LLC D/B/A JOHN DOUGHS  
256-258 COMMERCIAL STREET

Saki LLC d/b/a John Doughs ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, September 24, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigator Binienda and Velez's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

1. Investigators Binienda & Velez's Minimum Purchase Age Compliance Check Field Report, 6/19/2024;
2. ABCC Form 43, Transfer of License Approval, 5/20/2008;
3. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

**FINDINGS OF FACT**

1. On Wednesday, June 19, 2024, at approximately 6:00 p.m., Investigators Binienda and Velez ("Investigators") conducted a compliance check at Saki LLC d/b/a John Doughs.
2. An underage operative, working under the supervision of Investigators, was served an alcoholic beverage, one Angry Orchard Hard Cider. The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 12 since 2008.

## CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING**.




