Tobiko Ptown LLC d/b/a Waterford Inn & Spindler's ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, January 9, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Binienda and Velez's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Binienda and Velez's Minimum Purchase Age Compliance Check Field Report, 6/22/2023;
- 2. Licensee's Stipulation of Facts;
- 3. ABCC Licensing Authority Certification, Transfer of License Approved, 8/26/2022.

FINDINGS OF FACT

- 1. On Thursday, June 22, 2023, at approximately 5:40 p.m., Investigators Velez and Binienda ("Investigators") conducted a compliance check at Tobiko Ptown LLC d/b/a Waterford Inn & Spindler's.
- 2. An underage operative, working under the supervision of Investigators, was served an alcoholic beverage, one Corona Extra draft beer. The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 12 since 2022 with no prior violations.

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING**.
