At 9:04 a.m., the meeting was called to order by Dr. Carey.

### Board Business

- **Public Meeting Minutes of January 13, 2023:** After a brief discussion, a motion was made by Dr. Marshall, seconded by Dr. Brown, to approve the Public Meeting Minutes of January 13, 2023, with changes. The motion passed unanimously by a roll call vote.
- **Executive Session Minutes of January 13, 2023:** After a brief discussion, a motion was made by Dr. Marshall, seconded by Dr. Brown, to approve the Executive Session Minutes of January 13, 2023, with changes. The motion passed unanimously by a roll call vote.
- **Board Appointments:** Mr. Bialas announced that those members who are serving on an expired term may submit a cover letter and resume to Mr. Bialas if they wish to be considered by the new administration for reappointment. Board members also may recommend new candidates.

## Discussion

The Board directed Mr. Bialas to inform Dr. Greenwald that he may petition the Board to terminate his probation.

**Executive Session** (closed under G.L. c. 30A, § 21(a)(7) to comply with G.L. c. 4, § 7, ¶ 26(c) and G.L. c. 214, § 1B – adhering to the public records law and to preserve the confidentiality of medical record information)

At 10:02 a.m., a motion was made by Mr. O’Halloran, seconded by Dr. Marshall, to (1) exit the public meeting; (2) enter into executive session under G.L. c. 30A, § 21(a)(7) to comply with G.L. c. 4, § 7, ¶ 26(c) and G.L. c. 214, § 1B – adhering to the public records law and to preserve the confidentiality of medical record information to review a request for reinstatement and an examination accommodation request; then (3) enter into investigative conference under G.L. c. 112, § 65C to conduct a case interview and review new cases; and (4) at the conclusion of the investigative conference, not return to the public meeting. The motion passed unanimously by a roll call vote.
