Dear Governor Baker, Speaker Mariano, Representative Peisch, Commissioner Aigner-Treworgy,

Re: Private Pay Family Child Care Providers on the Early Education and Care Economic Review Commission

Knowing that time is of the essence and that the Early Education and Care Economic Review Commission has many critical reviews and reports to complete in a short time we collectively support appointing the following members: Jennifer Simpson and Beth Sidel. We are grateful for the opportunity to represent family child care providers at the table.

We do realize that while Private Pay is nearly half of Family Child Care providers in the state and that our letter, 50 strong, is only a minority of the field. Historically, non-subsidized, private providers have been underrepresented in state legislative policies as they all work primarily independently. We are writing as a group of Private Pay Family Child Care Leaders that has had the opportunity to engage monthly with Commissioner Aigner-Treworgy to make our recommendations. Unfortunately, many independent FCC providers may not even be aware of this new Commission. It is our hope that in the future a more adequate system, beyond our private facebook groups, allows a way to communicate and connect to all providers. There is great need for opportunities for advocacy, however, these also need to be published in a way that the field is aware of in order to increase participation that will continue to grow and strengthen the workforce.

We support Governor Baker appointing **Jennifer Simpson** as the *representative of family child-care* and Speaker Mariano, appointing **Beth Sidel** as the *private pay early education and care provider* in the commonwealth.
