NOTICE OF PUBLIC HEARING

Notice is hereby given that the Department of Mental Health promulgated emergency regulations on December 22, 2022 under the authority of M.G.L. c. 19, ss. 1, 16, 18 and M.G.L. c. 123, s. 2 and in accordance with M.G.L. c. 30A. A virtual public hearing will be held for the purpose of receiving written and oral testimony on the regulatory changes. The Department describes the substance of the actions as follows:

The emergency regulatory changes to **104 CMR 29.00 Application for DMH Services, Referrals, Service Planning and Appeals** set forth the criteria for authorizing specialized and additional services, including transition case management, for individuals in nursing facilities who have been identified as having a serious mental illness and for whom specialized or additional services have been identified that could facilitate discharge to a community setting. This emergency regulation demonstrates the Commonwealth's commitment to compliance with requirements of the federal Preadmission Screening and Resident Review (PASRR) process and its efforts to assure placement of such individuals in the least restrictive setting appropriate to their needs.

The regulations are now in effect for a 90-day period, subject to a public comment period, and final promulgation thereafter. The Department of Mental Health will be holding a virtual public hearing to receive oral and written comments as follows:
