The Board of Registration of Cosmetology and Barbering (“the Board”) is hosting a listening session for comments on Board regulations for 240 CMR 2.00 to 11.00, scheduled for **Tuesday, October 13, 2020 at 9:30 a.m. by conference call.**

During the listening session, members of the public may address the Board and offer comments and recommendations on proposed changes to current Board regulations.
