Notice of Request for Minor Revision to Chapter 91 License No. 10233**

Applicant: City of Boston Planning and Development Agency

Project Location: South Jetty adjacent to 31 Fid Kennedy Ave (Parcel L in the Raymond L. Flynn Marine Park (RLFMP), South Boston Designated Port Area (DPA), Boston, Suffolk County

Notification Date: September 24, 2025

Public Comments Deadline: October 24, 2025

Public Notice is hereby given of the Administrative Request by the City of Boston Planning and Development Agency to construct mooring infrastructure improvements to the South Jetty within Filled and Flowed Tidelands of Boston Harbor adjacent to 31 Fid Kennedy Avenue on Parcel L in the RLFMP and South Boston DPA, Boston, Suffolk County. The proposed project has preliminarily been determined to be a Water-Dependent Industrial Use.

Pursuant to RLFMP Chapter 91 License No. 10233, the use of Parcel L is required to be dedicated exclusively to Water-Dependent Industrial Uses or Accessory Uses thereto, and any Flowed Tidelands on a project site shall be devoted exclusively to Water-Dependent Industrial Use. The proposed activities as specified in Special Condition Nos. 5(a) and 5(d)ii of the License contemplates that any new or expanded structures for Water-Dependent Industrial Uses on any tidelands may be authorized through the Minor Revision Procedure set forth in Special Condition No. 6 of the License.

The Department will consider all written comments on this Application received by Friday, October 24, 2025 (Public Comments Deadline). Failure of any aggrieved person or group of ten (10) citizens or more to submit written comments to the Waterways Regulation Program by the Public Comment Deadline will result in the waiver of any right to an adjudicatory hearing in accordance with 310 CMR 9.13(4)(c). The group of citizens must include at least five (5) citizens who are residents of the municipality in which the project is located.
