 - a Chris provided updates for the ongoing surveillance season, confirming a sporadic outbreak of West Nile Virus. Additionally, Pioneer Valley traps were producing large numbers of mosquitoes, likely due to the favorable climate and rainfall. No EEE detected in Massachusetts as of 8/16.
 - b A plan was made for Greg to touch base with DPH to discuss their mosquito control operations in Western Mass.

 - a Interest in the PVMCD from Sen. Comerford's office is ongoing.

- b Merridith will be writing a letter to Sen. Comerford's office detailing the current roadblocks for the district, primarily dealing with the large surge in demand for membership with minimal funding.
- c The most pressing needs for the district were reiterated office space, trucks, seasonal help, etc.
