Board Business

• Public Meeting Minutes of August 14, 2020 and Executive Session Minutes of August 14, 2020: After a brief discussion, a motion was made by Dr. Jones, seconded by Dr. Glover, to approve the Public Meeting Minutes of August 14, 2020 and Executive Session Minutes of August 14, 2020. The motion passed unanimously.

Discussion

• Valor Act and Reciprocity: The Board discussed Dr. Alicia Ottati's Valor Act question, specifically whether she is eligible for licensure in Massachusetts under the Valor Act if she did not complete the required supervised post-doctoral experience before receiving her license in Virginia. The Board directed staff to invite Dr. Ottati to the next meeting to discuss her qualifications with the Board and to ask for her resume.

- 9.28.20 Email from D. Helfand re: Neurotherapy for Psychologists: The Board considered Dr. Helfand's letter, which asks whether specific types of neurotherapy fall within the scope of practice of a psychologist. After a brief discussion, the Board directed staff to respond to Dr. Helfand in the same manner as in the Board's previous letter to Dr. Rosenthal on a similar topic.
- 9.29.20 Email from J. Lexington re: Supervision and Teletherapy: The Board discussed Dr. Lexington's email, which asks whether teletherapy sessions may count toward the supervised experience requirement even if the patient, trainee, and supervisor

are not all in Massachusetts. After a brief discussion, a motion was made by Dr. Glover, seconded by Dr. Jones, to revise the "Emergency Policy on Supervision and Teletherapy" to eliminate the requirement that the patient, trainee, and supervisor must all be in Massachusetts, and to add language requiring trainees and supervisors to comply with other states' statutes and regulations, if applicable. The motion passed unanimously.
