



HMOs with MA Membership in Closed Network Plans less than 50,000 Members on 03/31/2021





HMOs with Massachusetts Membership less than 50,000 Members as of 03/31/2021














1st Quarter 2018 Share of Massachusetts HMO Market




1st Quarter 2019 Share of Massachusetts HMO Market
