




HMOs with MA Membership in Closed Network Plans less than 50,000 Members on 06/30/2021





HMOs with Massachusetts Membership less than 50,000 Members as of 06/30/2021














2nd Quarter 2018 Share of Massachusetts HMO Market




2nd Quarter 2019 Share of Massachusetts HMO Market
