## MEMORANDUM

RE: Appropriation for Fiscal Year 2022  
DATE: May 5, 2021

Required Fiscal Year 2022 Appropriation: **\$38,315,387**

This Commission is hereby furnishing you with the amount to be appropriated for your retirement system for Fiscal Year 2022 which commences July 1, 2021.

Attached please find summary information based on the present funding schedule for your system and the portion of the Fiscal Year 2022 appropriation to be paid by each of the governmental units within your system.

For the FY20 appropriation, we developed a methodology to settle the longstanding issue regarding the shortfall in prior appropriations due to the hospital privatization. Amortization bases were developed for both the City and the Housing Authority. The Housing Authority paid the entire outstanding balance in July 2019. The FY22 appropriation for the City continues to include an amortization of the shortfall.

The amounts shown in this memorandum reflect an assumed payment date of July 1. Our understanding is that the Housing Authority makes its payments monthly. The annual payment for the Housing Authority on a monthly basis is \$1,675,755.

The current schedule is due to be updated by Fiscal Year 2023.
