**FPS LIBATIONS LLC D/B/A PRESIDENTIAL LIQUORS
25 SCAMMELL STREET

FPS Libations LLC d/b/a Presidential Liquors (“Licensee”) holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (“ABCC” or “Commission”) held a hearing on Tuesday, September 30, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigators Gardner & Smiddy’s Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

1. Investigators Gardner & Smiddy’s Minimum Purchase Age Compliance Check Field Report, 6/4/2025;
2. ABCC Licensing Authority Certification, Transfer of License Approved 2/10/2020;
3. Licensee Stipulation of Facts.

FINDINGS OF FACT


1. On Wednesday, June 4, 2025, at approximately 4:52 p.m., Investigators Gardner & Smiddy (“Investigators”), conducted a compliance check at FPS Libations LLC d/b/a Presidential Liquors.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 16 oz can of Bud Light beer, for two dollars and forty-nine cents (\$2.49). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2020.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING**.


