**NOTICE OF SUSPENSION**

After a hearing on March 26, 2013, the Commission finds Stadium Quincy, LLC dba Stadium Bar & Grill in violation of 204 CMR 2.05 (2) Permitting an Illegality on the Licensed Premises, to wit: M.G.L. c. 138 §34c-Possession of an alcoholic beverage by a person under twenty-one years of age (4 Counts).

The Commission suspends the licensee's license for a total of six (6) days to be served. The suspension shall commence on Wednesday May 29, 2013 and terminate on Monday, June 3, 2013. The license will be delivered to the Local Licensing Board or its designee on Wednesday, May 29, 2013, at 9:00 A.M. It will be returned to the licensee Tuesday, June 4, 2013.

You are advised that pursuant to the provisions of M.G.L. c.138 §23, you may petition the Commission to accept an offer in compromise in lieu of suspension within twenty (20) calendar days following such notice of such suspension. If accepted, you may pay a fine using the enclosed form. All checks must be certified and accompanied by the enclosed form, which must be signed by a Massachusetts Licensed Accountant.

You are advised that you have the right to appeal this decision under M.G.L. c. 30A to Superior Court within thirty (30) days upon receipt of this notice.

Stadium Quincy, LLC dba Stadium Bar & Grill (the "Licensee") holds an alcoholic beverages club license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, March 26, 2013, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an Illegality on the Licensed Premises, to wit: M.G.L. c. 138 §34c-Possession of an alcoholic beverage by a person under twenty-one years of age (4 Counts). Prior to the commencement of the hearing, the licensee stipulated to the violation detailed in Investigator Velez's Violation Report.

The following documents are in evidence:

1. Investigator Velez's Violation Report dated November 21, 2012;
2. Massachusetts Driver's License of Caroline Toto;
3. Massachusetts Driver's License of Kimberly Lebel;
4. Licensee's Stipulation of Facts;

FACTS


1. On Wednesday, November 21, 2012 at approximately 9:30p.m., Investigators Carey, Keefe and Velez entered the licensed premises of Stadium Quincy, LLC dba Stadium Bar & Grill in order to determine the manner in which its business was being conducted.
2. Investigators' attention was draw to a group of youthful looking individuals who were standing near a high top table near the bar in possession of what appeared to be alcoholic beverages.
3. Investigators identified themselves and asked to see proof of legal drinking age.
4. Michelle Connolly, actual date of birth [REDACTED] (age 20), was observed in possession of a Michelob Ultra draft beer.
5. Ms. Connolly provided investigators with a Massachusetts Driver's License bearing the name Caroline F. Toto with a date of birth of [REDACTED] (age 22).
6. Investigators noted that the identification presented did not resemble Ms. Connolly.

7. Ms. Connolly stated that the identification was of someone else and not her.
8. Angela M. Ferragamo, actual date of birth [REDACTED] (age 20), was observed in possession of a Michelob Ultra draft beer.
9. Ms. Ferragamo provided investigators with a Massachusetts Driver's License bearing the name Bianca R. Desantis with a date of birth of [REDACTED] (age 25).
10. Investigators noted that the identification that was presented did not resemble Ms. Ferragamo.
11. Ms. Ferragamo stated that the identification was of someone else and not her.
12. Emiley Hajjar, actual date of birth [REDACTED] (age 20), was observed in possession of a Stella Artois draft beer.
13. Ms. Ferragamo provided investigators with a Massachusetts Driver's License bearing the name Bianca R. Desantis with a date of birth of [REDACTED] (age 25).
14. Investigators noted that the identification that was presented did not resemble Ms. Ferragamo.
15. Ms. Ferragamo stated that the identification was of someone else and not her.
16. Giulia Murphy, actual date of birth [REDACTED] (age 19), was observed in possession of a Michelob Ultra draft beer.
17. Ms. Murphy provided investigators with a Massachusetts Driver's License bearing the name Nicole E. Dasilva with a date of birth of [REDACTED] (age 24).
18. Investigators noted that the identification that was presented did not resemble Ms. Murphy.
19. Ms. Murphy stated that the identification was of someone else and not her.
20. Investigators spoke to the manager on duty, later identified as Todd Raffaelli.
21. Investigators identified the four underage individuals to Mr. Raffaelli.
22. Mr. Raffaelli stated to Investigator Carey that the pictures on the licenses did not look like the people present.
23. Investigators informed Mr. Raffaelli that a violation report would be filed with the Chief Investigator for further review.


### CONCLUSION

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2) Permitting an Illegality on the Licensed Premises, to wit: M.G.L. c. 138 §34c-Possession of an alcoholic beverage by a person under twenty-one years of age (4 Counts). Therefore, the Commission **suspends the license of Stadium Quincy, LLC dba Stadium Bar & Grill for a period of thirteen (13) days of which six (6) days will be served and seven (7) days will be held in abeyance for a period of two (2) years provided no further violations of chapter 138 occur.**

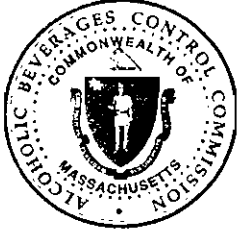

**Memorandum and Order On**

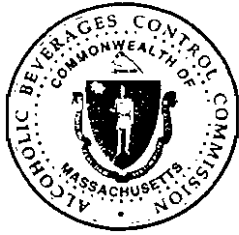

Stadium Quincy, LLC d/b/a Stadium Bar & Grill (the "Licensee") holds an alcoholic beverages license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, March 26, 2013, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an Illegality on the Licensed Premises, to wit: M.G.L. c. 138 §34C-Possession of an alcoholic beverage by a person under twenty-one years of age (2 Counts). Prior to the commencement of the hearing, Investigator Velez requested that the Commission dismiss two (2) counts as a result of a follow up investigation. The Commissioner allowed the request. The licensee stipulated to the violations at the commencement of the hearing. A Commission Decision dated April 9, 2013 originally stated there were four (4) counts and the penalty reflected a violation of four (4) counts. On April 10, 2013, the licensee submitted a request for reconsideration regarding the material error. The Commission issued Memorandum and Order on Licensee's Motion to Reconsider and Revise and Revoke Prior Disposition dated April 24, 2012 which allowed the licensee's request for reconsideration.

1. Investigator Velez's Violation Report dated December 5, 2012, 204 CMR 2.05 (2) Permitting an Illegality on the Licensed Premises, to wit: M.G.L. c. 138 §34C-Possession of an alcoholic beverage by a person under twenty-one years of age (2) counts;
2. Massachusetts Driver's License of Caroline Toto;
3. Massachusetts Driver's License of Kimberly Lebel;
4. Licensee's Stipulation of Facts to two (2) counts;
5. Registry of Motor Vehicles Printout for Michelle Connolly; and
6. Registry of Motor Vehicles Printout for Emily Hajjar.

## FACTS

1. On Wednesday, November 21, 2012 at approximately 9:30 p.m., Investigators Carey, Keefe, and Velez entered the licensed premises of Stadium Quincy, LLC d/b/a Stadium Bar & Grill in order to determine the manner in which its business was being conducted.
2. The Investigators' attention was drawn to a group of youthful looking individuals, who were standing near a high top table near the bar, in possession of what appeared to be alcoholic beverages.
3. Investigators identified themselves to the individuals and asked to see proof of legal drinking age.
4. Michelle Connolly, actual date of birth 02/19/1992 (age 20), was observed in possession of a Michelob Ultra draft beer.
5. Ms. Connolly provided investigators with a Massachusetts Driver's License bearing the name Caroline F. Toto, with a date of birth of 02/08/1990 (age 22).
6. Investigators noted that the identification presented did not resemble Ms. Connolly.
7. Ms. Connolly stated that the identification was of someone else, and not her.
8. Emily Hajjar, actual date of birth 4/11/1992 (age 20), was observed in possession of a Stella Artois draft beer.
9. Ms. Hajjar provided investigators with Massachusetts Driver's License bearing the name of Kimberly Lebel, with a date of birth of 03/20/1988 (age 24).
10. Investigators noted that the identification presented did not resemble Ms. Hajjar.
11. Ms. Hajjar informed the Investigators that this was someone else's identification, and that it was not her.
12. Investigators spoke to the manager on duty, later identified as Todd Raffaelli.
13. Investigators identified the underage individuals to Mr. Raffaelli.
14. Mr. Raffaelli stated to Investigator Carey that the pictures on the licenses did not look like the people present.
15. Investigators informed Mr. Raffaelli that a violation report would be filed with the Chief Investigator for further review.

## CONCLUSION

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2) Permitting an Illegality on the Licensed Premises, to wit: M.G.L. c. 138 §34C-Possession of an alcoholic beverage by a person under twenty-one years of age (2 Counts). Commission records for this licensee show that this is the first offense for this licensee; however, the licensee has been in business with this license since sometime after May 26, 2010, when the Commission approved an application to transfer ownership of the license to this licensee. Therefore, the Commission **suspends the license of Stadium Quincy, LLC d/b/a Stadium Bar & Grill for a period of six (6) days, of which six (6) days will be held in abeyance for a period of two (2) years, provided no further violations of chapter 138 occur.**
