MEMORANDUM AND ORDER ON LICENSEE'S REQUEST FOR RECONSIDERATION

SGKELLEY, INC. D/B/A THE CRAIC PUB 536 WASHINGTON STREET QUINCY, MA 02169

LICENSE#: 04423-RS-1006

SGKelley, Inc. d/b/a The Craic Pub (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission (the "ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, December 20, 2022, regarding an alleged violation of M.G.L. c. 10 § 33, 961 CMR 2:20 (1) – All tickets provided to the Licensed Sales Agent by the Lottery, and all proceeds from the sale of such tickets, shall at all times remain the exclusive property of the Lottery. All such proceeds shall be deposited by the Sales Agent into the trust account established pursuant to 961 CMR 2.16 (1), at such times and on such terms as the Director may from time to time require.

By decision dated December 20, 2022, the Commission found the Licensee in violation of the charges and indefinitely suspended the License effective forthwith until further written order from this Commission.

The Commission stated that it would consider issuing a further order upon written request of the Licensee showing good cause to reconsider this indefinite suspension. Good cause for the Commission to consider issuing a further written order revising the order of Indefinite Suspension will include, but not be limited to, the Licensee making payment to the Massachusetts State Lottery for the amount owed.

On December 21, 2022, the Commission received notice from the Massachusetts State Lottery Commission ("Lottery") that the debt had been paid.

CONCLUSION

Based on the evidence presented, the Commission reconsiders and reverses its prior order of INDEFINITE SUSPENSION of the license of SGKelley, Inc. d/b/a The Craic Pub effective forthwith.
