Humana Benefit Plan of Illinois, Inc. Initial Filing for Medicare Supplement Insurance Core Plan Rates Docket No. R2023-01

Notice of Hearing

As of February 6, 2023, the Humana Benefit Plan of Illinois, Inc. (“Humana”) completed the process for submitting to the Commissioner of Insurance (“Commissioner”) an initial rate filing for a Medicare Supplement Insurance Core Plan to be sold in Massachusetts. In accordance with the authority granted to the Commissioner by Massachusetts General Laws c.176K, the Division of Insurance (“Division”) will conduct a public hearing at 11:00 a.m. on March 8, 2023, to consider Humana’s request for approval of its proposed rates. The purpose of the hearing is to afford interested persons an opportunity to provide oral and written statements relating to those rates. The hearing will be held virtually using TEAMS, a digital meeting program. A copy of the filing is available upon request to the Division at doidocket.mailbox@mass.gov.

This proceeding is designated as Docket No. R2023-01 and shall be conducted pursuant to 211 CMR 121.00 et seq. Persons, other than statutory intervenors, who wish to intervene in this proceeding shall file with the Division a request for leave to intervene in accordance with 211 CMR 121.08.

Any person requesting to comment orally on the proposed rates at the March 8 hearing must submit a Notice of Intent to Comment no later than March 3, 2023, at 5:00 p.m. to doidocket.mailbox@mass.gov. Any person requesting solely to attend the hearing must submit a request to register no later than 5:00 p.m. on March 6, 2023 to doidocket.mailbox@mass.gov. Notices or requests must include the person’s name, telephone number and email address. An email with instructions for joining the hearing will be sent no later than 3:00 p.m. on March 7, 2023.

Any person who wishes to submit written comments on the filing may send a statement by electronic mail to doidocket.mailbox@mass.gov. Written comments may be submitted by electronic mail to that address until the hearing record is closed. All notices and written statements must refer to DOI Docket No. R2023-01.

A prehearing and technical conference will take place on March 8, 2023, immediately following the public comment hearing. All intervenors must attend.
