PAREA is Practical Applications of Real Estate Appraisal, a pathway for appraiser trainees to fulfill their experience requirements using a virtual environment to work in appraisal theory and methodology in simulations. Steven Sousa of MBREA gave a brief overview. Joseph Comperchio stated that this is very important to adopt. Scott Dibiasio of the Appraisal Institute asked the Board to begin developing regulations and described the adoption of PAREA by other states and development of platforms to be submitted to the Appraiser Qualifications Board for approval in coming months. The Board asked staff to invite AQB representative to next open meeting.
