

Overview

- Covid-19 has impacted transit operations throughout the Commonwealth
- For all Regional Transit Authorities (RTAs):
 - Ridership and associated revenue is down
 - Service is being provided at reduced schedules
 - Operational changes have been made to protect employees and customers that need to travel
- Federal funding (CARES Act) will provide significant support for the RTAs and the MBTA
 - MassDOT is working with the RTAs and MBTA to distribute



RTA COVID-19 Impacts

- Ridership is down
- Operating on modified service schedules (i.e. Saturday service levels)
- Providing PPE (gloves, masks, sterilization equipment) to drivers when available
- > 11 RTAs have implemented rear door boarding
 - 4 RTAs with non-rear door vehicles have implemented no fare enforcement policies or have installed driver barrier shields
- RTA employee impact:
 - > 10 RTA employees are known to have tested positive for COVID-19
 - BAT, LRTA and PVTA
 - > 1 case is presumptive positive
 - No deaths, 5 hospitalizations
 - 11 employees are known to be self-isolating/self-quarantining due to contact, out of state travel or are high risk
 - > 15 employees are on Family Leave/FFCRA



Federal CARES Act of 2020

- The Coronavirus Aid, Relief, and Economic Security (CARES) Act of 2020 provides \$25 billion in funding to support the transit industry's response to COVID-19
 - > \$22.7 billion for the Urbanized Area Formula Program (5307)
 - Funding for transit agencies in large and small urbanized areas (UZAs)
 - > i.e. Boston, Barnstable, Worcester, Springfield, etc.
 - \$2.2 billion for Formula Grants for Rural Areas (5311)
 - Funding for transit agencies in rural areas and for intercity bus
 - Includes \$30 million for Tribal Transit formula program
 - Beginning January 20, 2020, funding is available for all activities normally eligible under 5307 and 5311 at 100% federal share
 - > Operating expenses (including lost revenue, administrative leave of personnel)
 - Capital expenses (preventative maintenance, rolling stock, equipment, etc.)
 - Planning
- This week, the Federal Transit Administration (FTA) will be rolling out a toolkit to assist agencies in projecting the economic impacts of COVID-19 as they prepare to apply for CARES funds
