**DECISION**

**RALPHIE'S GAS & CONVENIENCE LLC D/B/A RALPHIE'S GAS & CONVENIENCE**

Ralphie's Gas & Convenience LLC d/b/a Ralphie's Gas & Convenience ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, July 8, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: Ch. 138 § 34 – Sale of Delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Gardner & Smiddy's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

2. ABCC Licensing Authority Certification, Transfer of License Approved 2/8/2021;

**FINDINGS OF FACT**

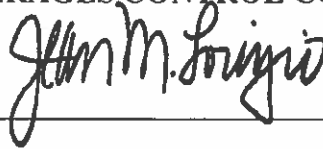
1. On Wednesday, April 30, 2025, at approximately 6:06 p.m., Investigators Smiddy and Gardner ("Investigators") conducted a compliance check at Ralphie's Gas & Convenience LLC.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 25 ounce can of Bud Light beer for three dollars and nineteen cents (\$3.19). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2021.

## CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a WARNING.
