## DECISION

### QUICK EXPRESS INC D/B/A GAS 44 1375 NEW STATE HIGHWAY RAYNHAM, MA 02767 LICENSE#: 90742-PK-1012 VIOLATION DATE: 4/09/2025 HEARD: 6/24/2025

Quick Express Inc d/b/a Gas 44 ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, June 24, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators McDonough & Smith's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators McDonough & Smith's Minimum Purchase Age Compliance Check Field Report, 4/9/2025;
- 2. ABCC Licensing Authority Certification, New License Approved 3/7/2024;
- 3. Licensee Stipulation of Facts.

# FINDINGS OF FACT

- 1. On Wednesday, April 9, 2025, at approximately 4:40 p.m., Investigators McDonough & Smith ("Investigators") conducted a compliance check at Quick Express Inc d/b/a Gas 44.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one Tropical Beer Hug Imperial IPA 19.2oz for three dollars and fifty cents (\$3.50). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2024.

#### CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a WARNING.
