**GREYHOUND PACKAGE STORE INC.
676 BROADWAY

Greyhound Package Store Inc. ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, October 25, 2022, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator David's Report.

FINDINGS OF FACT

1. On Wednesday, June 29, 2022, at approximately 5:17 p.m., Investigators David and Smith ("Investigators"), inspected the business operation of Greyhound Package Store Inc.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 24-ounce can of Bud Light beer for two dollars and eighty-five cents (\$2.85). The underage operative was not asked to produce identification.


3. Michael Arieta, Licensee, appeared at the Commission hearing and testified his employees had been trained to request identification from patrons, along with scanning the identification as part of the store's point of sale system on the register.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
