DECISION

V.B. GAS INC. D/B/A SAVE MORE GAS & CONVENIENCE 1348 NEW STATE HIGHWAY RAYNHAM, MA 02767 LICENSE#: 88975-PK-1012

V.B. Gas Inc. d/b/a Save More Gas & Convenience ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, November 29, 2022, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Smith's Report.

The following documents are in evidence:

- 1. Investigator Smith's Minimum Purchase Age Compliance Check Field Report;
- 2. Licensee's Accela Summary, New License Approved, 2/2/2017;
- 3. Licensee's Stipulation of Facts.

FINDINGS OF FACT

- 1. On Wednesday, June 29, 2022, at approximately 5:45 p.m., Investigators David and Smith ("Investigators"), inspected the business operation of V.B. Gas Inc. d/b/a Save More Gas & Convenience.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, a 24-ounce Coors Light beer, for three dollars and twenty-five cents (\$3.25). The underage operative was not asked for identification.
- 3. Bhavesh Patel, President of the Licensee corporation, appeared at the Commission hearing. The Commission was informed the Licensee has ensured all employees are TIPS trained and has recently purchased a scanner.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING.**
