

# Evolution of the Recycling Dividends Program (RDP)

- Purpose of RDP is to incentivize municipalities to implement best practices for waste reduction, reuse, and recycling.
- Demonstrate the effectiveness of our grants for achieving waste reduction goals. Adjust over time.
- RDP investment more than \$7 Million in RDP funds unspent.
- > Annual RDP Budget \$3 Million.

# Bulky Items – Reduce Options & Points

- Many municipalities in MA are charging fees to collect bulky items from residents (at least 69%).
- Progress in this criteria has remained stagnant over the past several years.
- > Few municipalities have claimed the option for 4 free items per year (<1%).
- ➤ In 2023, the funds attributed to RDP points for bulky collection was \$373K.

Bulky Items = upholstered furniture, wood furniture, toilets, sinks, & carpet.

### CHARM – Adjust Guidelines

- > Still required to collect 8 items. Mattresses valued the same as other items in this category.
- In order to get credit, municipality MUST list their site on Beyond the Bin.
- > Charm location can be spread out throughout the municipality.
- More changes expected in 2025.



# Curbside Recycling Regulations – Adjust Guidelines

- Options related to the "ADOPTION" of private hauler regulations are combined, for 1 point. To qualify, munis must:
  - Require bundled service and pricing for residential generators
  - Require bundled service for commercial generators
  - Require recycling of all generators (i.e., have a mandatory recycling reg.)
- Enforcement of private hauler regs is consistent, at 3 points.
- Other changes coming in Spring25 more focus on enforcement.

### Yard Waste – Remove Criteria

- Yard waste have been a waste ban material for 32+ years.
- Most municipalities in MA have programs to collect yard waste from their residents (at least 70%).
- Municipalities can implement whatever program works best for them.
- In 2023, the funds attributed to RDP points for yard waste was \$455K.



#### Timeline

- The following Grant Prerequisites are Due on February 15, 2024:
  - Annual Notification of Buy Recycled Policy
  - Recycling & Solid Waste Surveys (2022 and 2023 calendar years)
  - RDP Spending Report
- > Grant Applications will be released via ReTRAC in April 2024
  - Annual webinar for RDP and all other SMRP grants TBD
- Application period extends through mid-June 2024
- MassDEP evaluates applications over the summer
- Awards announced Fall 2024

# What About Spring 25 RDP?

- Increase the \$\$\$ value of points for the smallest municipalities Population 0-4,999
- Require RDP award funding to be placed in a dedicated account
- CHaRM mercury collection required to earn points in this section
- Curbside Recycling Regs focus on enforcement after 3 yrs.
- Organics expand options
- Solid Waste revamp section
- Textile Recovery remove; permanent collection bin or curbside collection required
- Waste Prevention Ed & Outreach links to RSMA, BtB, & Recyclopedia widget required
- Expect to Release Grant Details in June 2024 (after the Spring 24 Cycle)
