Broker to Salesperson Reinstatement Question

The question posed the board is if an individual becomes a broker can they stop using it and reinstate their salesperson license? After a discussion, the board determined that one cannot go backwards. If they obtain a brokers license, they cannot stop using it and reinstate their salesperson license.

Also, if someone holds a Business license (LLC, C, etc) and now want to close it and work as a sole proprietor, it is possible. The business license would have to be dissolved with the Secretary of State and that information forwarded to the Board. The Board would close out the business license.
