116 Salesperson by exam

- 4 Broker by exam
- 17 Businesses
- 13 Attorney Brokers
- 18 Reciprocal Salespersons
- 3 Reciprocal Brokers

PSI Exam Letter

The Board discussed the letter sent from PSI regarding their updates to the national portion of the real estate examinations. The Board has no issue with the recommended/current exam scores. The current exam scores are 70 for a salesperson and 75 for a broker.
