Executive Director Report

Colleen Maloney provided an update regarding the Elipse system. Colleen Maloney stated that since the new system went live, approximately 4000 people have renewed successfully. The exam approvals are being sent to PSI. We receive the files from PSI within 24-48 hours after an individual passes the exam. The continuing education issue with inactive and Attorney Brokers licenses has been resolved. The payment button issue has also been resolved.

The agency worked with MLS and the individuals who were initially having renewing problems, and those issues have been resolved.

The Chair thanked board staff for their efforts during this trying time.

Kristin Mitchell reminded everyone that we are a team of four and for everyone to continue to be patient while we work out any issues.
