ANTHONY'S COAL FIRED PIZZA OF READING LLC D/B/A ANTHONY'S COAL FIRED PIZZA 48 WALKERS BROOK DRIVE READING, MA 01867

Anthony's Coal Fired Pizza of Reading LLC d/b/a Anthony's Coal Fired Pizza (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, October 1, 2019, regarding an alleged violation of 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Di Cicco's Report.

The following documents are in evidence:

- 1. Investigator Di Cicco's Compliance Check Field Report;
- 2. Licensee Stipulation of Fact;
- 3. Copy of Receipt for Purchase of Alcohol;
- 4. Copy of Application Approved 7/8/2015.

FACTS

- 1. On Monday, April 1, 2019, at approximately 5:40 p.m., Investigators Kujawski and Di Cicco ("Investigators") investigated the business of Anthony's Coal Fired Pizza of Reading LLC d/b/a Anthony's Coal Fired Pizza.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a bottle of Bud Light beer for five dollars (\$5.00). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 12 since 2015 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. The Commission issues a **WARNING**.
