**Project Location** Interstate 495 (Mile markers 37.2 – 37.6) and Route 1A (Mile markers 10.1 – 10.8) in Wrentham <sub>3</sub>







- Route 1A (South Street) resurfacing , widening, and improvements from south of the Wrentham Crossing signalized intersection to approximately 400 feet north of the signalized intersection with the I-495 Northbound ramps.
- New ramp (about 0.5 mile long) construction from Route 1A NB to I-495 SB, which includes embankment placement, earth and bedrock removal, full depth construction, and shoulder reconstruction along I-495 SB.
- Side paths along both of Route 1A and new cement concrete pedestrian curb ramps.
- Two new cement concrete retaining walls along Route 1A beneath the I-495 overpasses to support the new side paths.
- Traffic signal reconstruction/replacement at the intersections of Route 1A & Wrentham Crossing, Route 1A & Wrentham Village Premium Outlets, and Route 1A & I-495
- Other work: clearing/grubbing, earth and bedrock excavation, stormwater detention & treatment area construction, drainage system improvements, water mains & hydrants relocation, granite curbing installation, driveways, guardrail, landscaping, pavement markings, and signing.



### **Overview**

#### Purpose & Need/Traffic Impacts

#### Purpose & Need

- Weekends traffic congestion at Premium Outlet Boulevard intersection requires local police monitoring and manual control.
- Major holiday shopping events require extensive planning with town officials, and local and state police; strategies include traffic diversion, George and Berry Streets and Nickerson Lane closures.
- Future new commercial and residential developments will further impact Route 1A operations.

#### Traffic Impacts

- For I-495 SB new entrance ramp: Most work is off-road with limited impact to traffic. But night work closure of I-495 SB right lane for new ramp entrance (at I-495 SB) is anticipated.
- For Route 1A: Access to local businesses and residences is maintained at all times; daily shoulder and lane closures during off peak hours are anticipated for work within the roadway footprint (paving, drainage), roadside construction to occur during regular construction hours.
- Construction will take approximately five and a half years to complete.
