\*Community Shared Solar Participants do not directly purchase solar electricity. Instead, participants purchase credits in the form of Net Metering Credits or Alternative On-Bill Credits, which may or may not reduce customers' total electricity costs depending on market conditions and the specific terms of a credit purchase agreement. <u>Due to the nature of solar generation</u>, <u>please expect generally higher billing prices in the summer and lower billing prices in the winter.</u>
