Reemployment Services and Eligibility Assessment (RESEA) Training **Subject:**

Purpose:

To notify Local Workforce Development Boards, One-Stop Career Center Operators, and other local workforce partners of the upcoming RESEA Training in February. The DCS RESEA/LMI Training Team, as well as DUA Staff, will conduct the training sessions.

This is a comprehensive training, covering the core basics of the RESEA program and process intended specifically for any new employees or staff recently assigned to the RESEA Program. All staff conducting RESEA Reviews, scheduling Career Center Seminars and/or providing reemployment services to RESEA customers can benefit from this training and must attend this training prior to conducting RESEA Review. Each attendee will receive a copy of the RESEA Policy and Procedures program manual to use as an informational guide to assist in working with RESEA customers and navigating the program process. This session will consist of an overview of the RESEA Program with emphasis on the RESEA Program processes, MOSES data entry, common errors, and reports that are available to assist with managing the program, and communicating with DUA.

Background: The RESEA program has provided claimant entry to a full array of reemployment services available at Career Centers and has helped to ensure that claimants comply with all UI eligibility requirements. Individuals filing UI claims are

active job seekers who, through the state's RESEA Program are made aware of the variety of reemployment services that are available to them. They are referred to the appropriate employment opportunities and reemployment service for their individual needs.
