Background: The DOL ETA announced approximately \$66 million in grant funds authorized by section 169 of the Workforce Innovation and Opportunity Act (WIOA) for research and evaluations to improve the management and effectiveness of workforce programs and activities such as Reentry Projects (RP). Projects funded under this FOA are authorized under Section 212 of the Second Chance Act of 2007. Projects are required partners in the American Job Centers (AJCs) under WIOA sec. 121(b)(1)(B) and must share in the funding of the One-Stop Delivery

The purpose of these grants is to use evidence-based and informed interventions, or new interventions that theory or research suggests are promising, (or a combination of both) to improve employment outcomes of adults ages 25 and older that were formerly incarcerated in the adult criminal justice system and released within 180 days or young adults between the ages of 18 to 24 who have been involved in the juvenile or adult justice system. Grants for adults and young adults **must be located in high-poverty, high-crime communities**.

ETA plans to award up to \$1,500,000 each to approximately twenty (20) CBOs, approximately thirteen (13) proposing to serve adults and approximately seven (7) proposing to serve young adults.

Eligible Applicants:

Eligible applicants are either an intermediary organization (defined for the purpose of this Announcement as organizations that have an affiliate network or offices in at least 3 communities & across at least 2 states) **or** as a community-based organization (CBO) (defined for the purpose of the Announcement as organizations with single sites or multiple sites within 1 state). **State and local government fall into the CBO category.**

Applicants may propose to serve either adults (ages 25 or older) or young adults (ages 18-24) in each application but may not serve both adults and young adults in the same application. Eligible applicants targeting Adults are limited to nonprofit community-or faith-based organizations with IRS 501(c) (3) nonprofit status, including women's and minority organizations. Applicants targeting adults must also be located in an urbanized area or urban cluster, as defined by the U.S. Census Bureau.

Eligible applicants targeting Young Adults are limited to either community- or faith-based organizations with IRS 501(c) (3) nonprofit status, including women's and minority organizations; state or local governments; or any Indian and Native American entity eligible for grants under Section 166 of WIOA.Applicants may submit up to one application to serve adults and up to one application to serve young adults for a total of two applications. Applicants may include current or former DOL grantees; new applicants that have not received previous DOL grants are also encouraged to apply.
