Board Business:

1. At 9:01 a.m., the meeting was called to order.

- 2. Dr. Jacobo reviewed evacuation instructions.
- 3. On a motion by Dr. Sanchez, seconded by Dr. Scherer, the Board voted to approve the Board Meeting and Executive Session minutes for the April 14, 2017 meeting. All in favor with Dr. Bistis and Ms. Allen abstaining.
- 4. There was no correspondence.
- 5. Discussed Dr. Podsiadlo applicant. The board, by unanimous vote on a motion by Dr. Scherer and seconded by Ms. Allen, agreed to require the applicant to take a racial-ethnic 3 credit course to meet the educational requirements for licensure.
- 6. Discussed applicant, Dr. Schinaman. The board agreed, by unanimous consent, to invite the applicant to meet with the board for review of ethical and moral character for consideration of license.
- 7. Discussed applicant, Dr. Ronayne. The board, by unanimous vote on a motion by Dr. Scherer and seconded by Dr. Bistis, denied the applicant's appeal of the board's decision.
- 8. On a motion by Dr. Sanchez, and seconded by Ms. Allen, the board agreed to approve all of the administratively reviewed applicants.
- 9. The board engaged in discussion of board member appointments and the process for renewals.

- 10. At 9:12 a.m., on a motion by Dr. Bistis, and seconded by Dr. Scherer, all were in favor, the Board voted to enter into closed session for the purpose of conducting investigative conferences, pursuant to G. L. c. 112, § 65C, for: 20150928PY012-IT-ENF (Attorney Pixley presented counter offer submitted the by counsel of the licensee), and PY 2016-000884-IT-ENF (Attorney Puelo present representing licensee).
- 11. At 11:06 a.m., on a motion by Dr. Scherer, seconded by Ms. Allen, the board voted to exit closed session and to enter open session. Following a roll call vote, all in favor, the motion passed.
