RMV Service Updates and Reminders

Worcester RMV Service Center

- New location opening by mid August at 50 Southwest Cutoff, Suite 1E
 - WRTA public bus stop directly in front of facility and convenient access to Routes 20, 122, 9 and Interstate 90
 - 2 walk-up exterior transaction windows for commercial agents and on-site motorcycle testing course
 - Approximately 350 parking spots







RMV Service Updates and Reminders

Low Plate Lottery

- Customers can enter the plate lottery online using the myRMV Online Service Center. The lottery is online submission only; there is no paper application available.
- The deadline to enter the 2022 Low Plate Lottery is 9/2/22 at 5:00 p.m.
- This year there are 198 plates available for the low number plate lottery.
- Some of this year's low plates are F7, 36, 78K, X44, 1S, and 6666.

RMV Service Updates and Reminders

REAL ID – Reminder

- Compliance date is less than one year away, 5/3/23
- Currently, Massachusetts is at 44% REAL ID adoption
- Plan ahead and be prepared by having available all of the required documentation (proof of lawful presence, residency, and SSN)) needed to secure a REAL ID
- Visit Mass.Gov/ID for acceptable documents

Projects

- Driver History Record (DHR)
 - DHR is an electronic service by AAMVA that provides states with new measures to improve the administration of non-CDL driver history. Specifically, DHR:
 - supports the electronic exchange of out-of-state convictions and withdrawals
 - provides visibility of individuals that may have more than one DHR
 - sets rules for maintaining Driver History in a standardized manner.
 - DHR was successfully implemented in MA during weekend of June 25 and 26, 2022.
 - South Carolina, Maryland, and Minnesota will join DHR by end of 2022 and 8 more states scheduled for 2023

Projects, continued DL/ID RFR

- RMV is seeking a vendor to provide a Driver's License and Identification (DL/ID) card solution and associated services. Services include customer image capture, signature capture, and centralized card manufacturing/mailing of several DL/ID types and other RMV issued credentials. Additional services and equipment that will be required include biometric identification processes, document scanning and authentication, knowledge/permit exams, and portable workstations.
- RFR will be posted on 7/20.


RMV mailing services/profit sharing RFR

- RMV's current vendor (Globe Direct) who prints all DL/ID reminders, registrations, and registration renewal reminders notified the RMV that they will begin shutting down its operations over the next couple of months, with a full business closure by the end of the year.
- The RMV sends approximately 2.7 million renewal notices, approximately 3.2 million registrations, and approximately 1 million License/ID renewal reminders annually.
- Vendor responses to RFR were due on 7/15 4 responses received


