RMV & Department of Corrections Re-Entry Program

- The RMV began visiting nine Department of Corrections (DOC) facilities the week of March 4th to issue Mass IDs to new applicants.
- DOC purchased a mobile driver's license workstation so an RMV representative can visit DOC facilities throughout the state to capture photos/signatures and review the soon to be released applicant's identity documents- before issuing the Mass ID.
- This is an extension of the partnership that has been in place to issue IDs to soon to be released individuals who already exist in the RMV's system.


