### **DECISION**

AZEVEDO'S MINI MARKET, LTD 537 WINTHROP STREET REHOBOTH, MA 02769 LICENSE#: 102000028 HEARD: 08/14/2012

Azevedo's Mini Market, Ltd. (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, August 14, 2012, regarding an alleged violation of 204 CMR 2.05(2), to wit: c.138, §34. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Guarino's Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigator Guarino's Compliance Check Field Report dated May 21, 2012; and
- 2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

### **FACTS**

- 1. On Monday, May 21, 2012 at approximately 5:29 p.m., Investigators Carey and Guarino conducted an investigation of the business operation of Azevedo's Mini Market, Ltd.
- 2. An underage operative working with investigators purchased an alcoholic beverage, a twelve ounce (12 oz.) can of Natural Light beer for one dollar and fifty cents (\$1.50). The underage operative was not asked for identification.

### **CONCLUSION**

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2), to wit: M.G.L. c. 138, §34. Therefore the Commission suspends the license for four (4) days of which two (2) days will be served and two (2) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
