MEMORANDUM AND ORDER ON  
LICENSEE'S REQUEST FOR RECONSIDERATION  
OF INDEFINITE SUSPENSION

On January 24, 2013, the Alcoholic Beverages Control Commission (the "Commission") received a facsimile transmission of a letter from Steven R. Lombardi, President of Hillside Country Club By Lombardi's, Inc. dba Hillside Country Club By Lombardi's ("the Licensee" or "Lombardi's"). On January 24, 2013 the Commission received an electronic mail transmission from Attorney Christopher Mulhearn who notified the Commission for the first time that he is now representing the Licensee regarding this matter. On behalf of the Licensee, Mr. Lombardi and Attorney Mulhearn requested the Commission to reconsider the indefinite suspension of this license ordered in the Commission Decision dated January 17, 2013.

Notwithstanding the fact that according to Commission records the licensee received notice via first class mail at the licensed premises and failed to appear at a scheduled hearing, the Commission hereby **ALLOWS IN PART** the Licensee's request for reconsideration.

The Commission will stay the previously issued order of indefinite suspension only to allow the licensee to sell and deliver alcoholic beverages on Saturday, January 26, 2013 from 6:00 p.m. -12:00 a.m. to only the attendees of the previously scheduled function described by Mr. Lombardi in his letter dated January 24, 2013; provided however, that all of the monies received from this function shall be remitted on or before Monday, January 29, 2013 at 9:30 am to the Department of Unemployment Assistance and provided further that the licensee is hereby ordered to appear before the Commission at a hearing on Monday, January 28, 2013 at 9:30 a.m. to review the Licensee's compliance with this Memorandum and Order. The Licensee shall bring to this hearing all receipts and invoices from the aforementioned function.

The Request for Reconsideration of the Order of Indefinite Suspension ordered in the Commission Decision dated January 17, 2013 is in all respects **DENIED**.
