

This could attract carpenter ants and certain types of flies. ** ** superior clerks office- east office window- i found mouse droppings in the heater. I would ask to have this area cleared of the heater cover and clutter to allow for a full inspection. ** Regular monthly service conducted. I checked in and out with Al and reviewed my service notes with him. I inspected and serviced the second and third floors. Al complained about seeing very small flies in some offices. The flies i found appeared to resemble fungus gnats. I told Al, changing the soil and not over watering the soil in potted plants would help, but also, adding a fan to move the air around these offices could also help.
