





#### Conciliations Resolved v. Referred to Conference





Dispute Resolution: Fluctuations in the conference & hearing queues will depend upon number of cases being referred from conciliation, conference order appeals, judges scheduling cycles, continuance requests and regional variations. In addition, during FY 2024 attorneys have requested a total of 2,728 continuances. For FY 2023, there were 7,912 continuances.





Currently, the average waiting period for a conference is 8 to 16 weeks.





First Reports of Injury – FY 2023 v. FY 2024 as of 12/31/2023




First Report of Injury (FRI) filings for December were 2,269. Total FRIs filed for FY 2024 are 15,872. The total FRIs file for FY 2023 were 32,803.






#### Cases Filed by Month



The number of Cases filed for December 2023 was 751. Total cases filed for FY 2024 stands at 5,219.





The DIA conducted 5,057 total compliance checks and 135 field investigations in December. In addition, the unit sent out 1,628 compliance letters. As a result, 1,900 employees are now covered by workers' compensation insurance in FY 2024. For FY 2023, DIA conducted 64,506 compliance checks. As a result of these efforts, 4,356 employees now covered by WC insurance who were not previously protected by a policy.




In December, the DIA issued 90 Stop Work Orders (SWO) with 9 default for a total of 662 for FY 2024. Fine collection for FY 2024 total of \$729,239 For FY 2023 a total of 1,375 SWOs were issued, and total fines collected was \$936,757.






#### Uninsured Claims by Occupation & Industry - FY 2024



As of December 31<sup>st</sup>, 59 uninsured injuries have been reported to the WCTF for Fiscal Year 2024. For Fiscal Year 2023, a total of 95 new Sec. 65 injuries were recorded. Please note, claims may be determined to be insured or uninsured after they have been filed.








As of the end of last month, payments against open claims in FY 2024 stands at \$2,796,672. Please note that claims paid in the current fiscal year may have occurred in prior year. The WCTF issued \$7,726,621 in payments against open claims during FY 2023.

The Civil Litigation Unit make every effort to recover monies owed by utilizing the authority of M.G.L. Chapter 152 to recover money paid on uninsured claims through legal action against the employer in question.







#### Second Injury Fund Budget & Payments by Fiscal Year






Sec. 37/37A claims are filed by insurers who are seeking reimbursement of up to 75% of benefits paid for a second injury per the statute. In addition, the numbers indicate final payments have been registered in the state accounting system known as MMARS. Additional payments may be in process and are not yet registered in MMARS at the time of this publication.

# COLA Reimbursement Payments to Insurers by Fiscal Year.






#### **Assessment Collections**
