Hingham Road Diet Pilot Project



- Lane reduction pilot through July 30th
- 4 lanes to 2 lanes to create pedestrian and cyclist travel lanes
- Effort by MassDOT and Hingham to improve safety for the Summer Street corridor.

Holding Public Meetings

- May 24 public meeting on plans to replace Bass River Bridge carrying Rt. 28 traffic between Yarmouth-Dennis
- \$17.25 million project in design phase
- Construction scheduled to start 2020
