MOTION OF COMCAST PHONE OF MASSACHUSETTS, INC. FOR EXTENSION OF TIME TO REPLY TO MOTIONS TO DISMISS

Intervenor Comcast Phone of Massachusetts, Inc. ("Comcast") respectfully moves that the Department of Telecommunications and Cable ("the Department") extend the time within which Comcast can file a reply to motions to dismiss in this proceeding to and including Wednesday, March 5, 2008. As grounds for this motion, Comcast states:

- 1. The Department established a procedural schedule on February 12, 2008 that provides for the filing of motions to dismiss on February 27, 2008 and for filing of replies to such motions on March 3, 2008.
- 2. Pursuant to this schedule, XO Communications Services, Inc.; RNK, Inc. d/b/a. RNK Communications; PAETEC Communications, Inc.; and One Communications, Inc., filed motions to dismiss.
- 3. Comcast wishes to file a reply to these motions. The undersigned outside counsel for Comcast, the Mintz Levin firm, however, has recognized that it has a conflict of interest as result of the interventions and alignment of parties. Mintz Levin also represents One Communications and RNK, Inc. (parties to these proceedings) in matters unrelated to these proceedings, and it has become apparent that the interests of Comcast in these proceedings are adverse to those of One Communications and RNK, Inc.

Accordingly, Mintz Levin's continued representation of one client adverse to the interests of other Mintz Levin clients would be a violation of Rule 1.7 of the Massachusetts Rules of Professional Conduct absent a waiver of the conflicts of interest. The conflicts have not been waived. In these circumstances, Mintz Levin is required to withdraw from representation of Comcast pursuant to Rule of Professional Conduct 1.16(a)(1).

- 4. This motion is one of the steps required by Rule 1.16(d) of the Massachusetts Rules of Professional Conduct, to enable termination of representation because of a conflict without prejudice to the client losing the services of counsel responsible for representation in this proceeding. Mintz Levin recognized at the end of last week that it has to withdraw and so notified Comcast at the earliest practicable opportunity, which was on Saturday, March 1. Comcast has been in the process of engaging successor counsel over the weekend, but has not completed the process and therefore is unable to complete the filing of a reply to pending motions to dismiss today.
- 5. Comcast therefore seeks this extension of time to allow an orderly transition of the representation and enable new counsel to file replies on behalf of Comcast not later than March 5. The other parties to this proceeding will not be prejudiced by this brief delay in the filing of the replies.
- 6. We are authorized to state that the moving parties on the pending motions to dismiss XO Communications, Inc., RNK, Inc., PAETEC Communications, Inc. and One Communications, Inc. assent to this motion.

For the foregoing reasons, Comcast respectfully requests that this Motion to for Extension of Time be granted.
