Addressing the Middle Skills Gap Grant Program

Purpose:

To provide you with notification of the Request for Proposals (RFP) for the Workforce Competitiveness Trust Fund (WCTF) Addressing the Middle Skills Gap Grant Program issued by Commonwealth Corporation and funded by the WCTF.

The Addressing the Middle Skills Gap Grant is designed to address the gap between the skills held by workers and the skills needed by employers for jobs that require more than a high school diploma but less than the equivalent of a 4-year degree.

Background: This solicitation is offered by EOLWD, funded by the WCTF and administered by Commonwealth Corporation. Grant funds may be used to train Massachusetts residents who are either un/underemployed or disconnected young adults. Applicants may also propose to allocate a portion of their grant funds to train incumbent workers who are either Massachusetts residents or work in a Massachusetts establishment (see Section 3 of Attachment A).

> \$4.5 Million is available and will be awarded based on the Regional Funding Allocation, with individual grant awards not to exceed \$350,000 (see Section 5 of Attachment A). Awardees will be required to provide a 30% match on total awarded funds.

Contracts will be issued for a maximum duration of 3 years. All training and placement activity must be concluded by the end of the second year; postplacement support must be provided to each participant for one year. This may continue into and potentially through the end of the third grant year.
