This feature is accessed by pressing the pound ("#") button on the keypad and entering a PIN code.

Subscribers also are able to track their account balances because at the beginning of calls subscribers are provided the amount of monetary value in their accounts. All balances may be accessed on a real-time basis through the handset by dialing #6673.
