**4. Discussion on the 2020 Annual Report**

The Committee among themselves deliberated on the 2020 Annual Report and they discussed on inserting additional edits to the annual report. The suggested edits were made by Becky Michaels, ironed out by Fred Ryan and collectively collaborated by the subcommittee members of the annual report. Spencer talked about the Governor's Task Force on Hate Crimes and stated how reports need to be factual.

Fred Ryan made a motion to have Spencer Lord draft a paragraph to capture this conversation and not to name a crime victim in the annual report and vote on the annual report in January. John Millet second the motion. Roll call was taken. Majority of voters were not in favor.

Carolyn Boyes-Watson-Thanked Strong Oak for the opening remarks and was happy to hear what she was saying. This is hard to do but we have had a heartfelt conversation. Maybe do these more often? Is this a way to convene in the future?

Susan Jeghelian- Truly appreciate the work. Authenticity could come through, truthful, open and honest.

Becky Michaels-Sad to have missed such an important conversation. Was in court dealing with cases.

Allison Cartwright- Tired! Exhausted. I'm a black woman working for CPCS. Fighting constantly for Black/Brown clients. I feel it. I live it. I have three degrees; at times I don't feel respected or valued. We need to be in a place of respect. I'm exhausted!

Kara Hayes- I see you Allison. Is there respect here for me? Will I be equal? Will my feelings be confidential? I can't talk to this group safely.

Scott Taberner-without RFR we could inventory our partners and neighbors. Urge to work the inventory process.

Erin Freeborn- I'd like us to spend some time as a group to determine our vision, where we should go from here?

Undersecretary Peck-had to jump off the call and attend another meeting.

Maria D'Addecio-happy that these conversations are ongoing.

Kathy- the Committee should be more inclusive and broader. Other voices need to be at the table. Need new perspective.

Susan Maze-Rothstein-here to support Strong Oak today. Truth telling from the heart. Kara Hayes brought up good points. Establish guidelines. It is important if circle process continues to be implemented.

Strong Oak ends the circle by being moved on what people have expressed. The values, the commitments, the groups and all the voices that were heard.
