DECISION

PATSY, INC. DBA RENZO

Patsy, Inc. dba Renzo (the "Licensee") holds an all alcohol license issued pursuant to Massachusetts General Laws Chapter 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing Tuesday, November 1, 2011, regarding an alleged violation of M.G. L. Ch. 138, §12 (7 counts). Prior to the commencement of the hearing the licensee stipulated to the facts detailed in Investigator Paul Capurso's Report.

The following documents are evidence:

1. Investigator Paul Capurso's Report;
2. Stipulation of Facts; and
3. Receipts (copy).

There is one (1) tape of this hearing.

FACTS

1. On Tuesday, June 28, 2011, at approximately 2:00p.m., Investigator Doyle and Capurso entered the license premise in order to investigate the licensee's pending application, which sought to license an outdoor patio seating area and to address a complaint regarding loud noise and altercations coming from Patsy, Inc. dba Renzo.
2. While inspecting the area their attention was drawn to patrons who were seated on the patio in possession of alcoholic beverages.
3. The bartender called the manager, Rose Sharry, who arrived a short time later.
4. Investigator Capurso informed Ms. Sharry of the violation and she replied that they were told that they were allowed to serve alcoholic beverages on the patio.
5. The waitress provided Investigator Capurso with copies of the customers' checks, which show there were a total of seven (7) beers sold to patrons seated on the patio.
6. Investigator Capurso informed Ms. Sharry that a report would be submitted to Chief Investigator for review and exited the premises thereafter.
7. Administrative review of the file indicates the licensee has no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated M.G. L. Ch. 138, §12 (7 counts). The Commission **suspends the license for seven (7) days of which seven (7) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.**
