




Notable Project Successes

- Methuen Rotary Project Interchange reconstruction 193/RTE 100 & 113
 - completed within original budget of \$66,385,292.70
 - reached substantial completion 3 months ahead of schedule
- Woods Memorial Project Bridge Replacement
 - projected to be completed within original budget of \$81,310,058.29
 - projected to reach full beneficial use 8 months ahead of schedule
- Springfield Viaduct Rehabilitation Project
 - Projected to be completed within original budget of \$176,886,122.99
 - Achieved full beneficial use milestone ahead of schedule and is projected to meet remaining milestones for substantial and final completion
 - Successfully coordinated without disturbance to MGM Casino opening

Current Activities

Contractor is performing borings at the North and South Piers, demolition of existing fenders system and establishment of Stage 1A work zone. Demolition of the West Sidewalk is scheduled to start mid December 2018.

EverSource is scheduled to continue work for the month of December, schedule delayed due to discovery of concrete Slab and timber platforms at the South End of the Bridge.

Project Risks

Submittal, procurement, fabrication, and delivery of the temporary utility bridge. Permit amendments for Temporary vehicular bridge.

Extensive utility coordination are critical to keep schedule and relocation of the utilities for the temporary utility bridge.
